Honorarium: As approved by the University for Self finance programs.

Application Fee: Rs. 1000/= (INR) has to be paid as Demand Draft (DD) in favour of "The Director, IET Lucknow" payable at Lucknow. Scanned copy of the DD has to be uploaded with the online application. Candidates are required to bring original DD along with the printed copy of the Application Form with all the annexures at the time of written test/interview. Separate Application and Separate Fee is to be submitted/deposited by the applicant while applying against different Programs.

Last date of filling online application form: 15/07/2024 (24:00 Hrs Midnight).

Important Instructions

- 1- Interested and eligible candidates are requested to fill prescribed Online Application Form available on the Institute Website <http://www.ietluicknow.ac.in> and upload the scanned copy of DD for payment of the required application fee.
- 2- Only those applications, who have uploaded the scanned copy of DD for payment of required application fee shall be considered valid. Incomplete applications or applications without scanned copy of DD shall be summarily rejected and no communication in this regard shall be entertained.
- 3- The schedule of Test/Interview shall be notified on the Institute Website <http://www.ietluicknow.ac.in> . The candidates are required to keep on visiting the Institute Website regularly and report for Test/Interview in the Institute accordingly. No separate intimation, written or verbal will be sent to the applicants.
- 4- The applicant must bring the three set of printed hard copy of the filled Online Application Form along with their original certificates testimonials and original DD on the scheduled date(s) of Written test/Interview.
- 5- Candidates are also required to bring Self attested Photo copies of relevant degree & experience certificate, passport size photograph along with proof of identification at the time of Interview, failing which they shall not be allowed to appear in Interview.
- 6- Applicants must fully satisfy themselves about their eligibility as prescribed by AICTE/UGC, before appearing in the Interview. If an applicant is inadvertently allowed to appear in the Interview who otherwise dose not fulfill the minimum eligibility requirements, he/she cannot, at a later date use that as right to claim that he/she meets the eligibility requirements. If at any stage it is found that documents are incorrect the candidature of the applicant will be cancelled irrespective of stage of process.
- 7- Any corrigendum/changes/updates shall be made available only on the Institute Website <http://www.ietluicknow.ac.in>. The candidates are required to keep on visiting the Institute's Website regularly for updates, if any. No separate/individual communication shall be accepted.
- 8- The results of the interview shall be notified through Institute website after approval of the competent appointing authority. No correspondence shall be entertained during the process of the selection.
- 9- The Institute has right not to fill the vacancy/vacancies and no correspondence in this regard will be entertained.
- 10- The Institute reserves the right to withdraw and advertised post(s) at any time without giving any reason. The number of vacancies may change.
